American alligators... threatened species or hunter's prey? Sadly in Florida, the answer is both.

The Florida Fish and Wildlife Conservation Commission (FWC) will again host its barbaric alligator hunt, kicking-off this special permit season on August 15, 2009.

The American alligator is listed as an Appendix II species under an international treaty called CITES. Appendix II lists species that are not necessarily now threatened with extinction but that may become so unless trade is closely controlled. This listing provides federal protection for alligators but allows the state to manage and control programs. Permits for trade and hunting in Florida can only be granted if the FWC is satisfied that certain conditions are met, above all that trade and kills will not be detrimental to the survival of the species in the wild. Since the alligator is listed by the State of Florida as a Species of Special Concern, they can be legally killed only by individuals with specially issued permits.

Under the guise that money raised by the killing of alligators will benefit the overall population, the state claims that the hunt is justified. However, with a stated goal of the hunt being used to "manage Florida's alligator population for its long-term well-being and the benefits of users," ARFF purports that the FWC is biased toward the so-called "benefits" to hunters. Non-hunters, who constitute the vast majority of Floridians, pull no weight in this process which is clearly geared toward raising money at the expense of alligators.

Florida's alligator hunt is barbaric. Alligators are snagged with barbed hooks, pierced with arrows, stabbed with harpoons, and shot with a firearm called a "bangstick." Regulations state that alligators must be killed before being dragged into a boat, but the improper placement of the bangstick frequently renders the alligator only temporarily unconscious. There's nothing romantic about horses subjected to intense heat & traffic!

Horses used by the carriage industry in Florida are subjected to blistering heat and humidity, hot pavement and constant exposure to the sun, traffic congestion, exhaust fumes, long hours, inadequate amounts of rest, and little or no water throughout their work days.

Unfortunately, horses pulling heavy carriages are a sad but common sight on St. Augustine's busy streets. Accidents involving horse-drawn carriages occur frequently in St. Augustine and have resulted in injuries to horses and people. The City of St. Augustine has consistently refused to take steps to protect horses forced to pull carriages during the hottest months of the year. ARFF will speak before the City Commission this July to ask the city to enact a ban on horse-drawn carriages. Your letter to the commission in support of ARFF's request will be of significant value!

You Can Help

Please contact Mayor Boles and the St. Augustine City Commission and ask them to prohibit carriage horse rides. Let them know that other Florida cities have similar bans, including Palm Beach, Pompano Beach, Key West and Panama City Beach. If you are a tourist, tell them that you avoid cities that support the exploitation of animals for entertainment. *Contact:*

Illegal in Florida since 1972 — on sale at Gander Mountain in 2009?!

Leghold traps are cruel devices that have changed little since they were invented in the 1800s. An animal stepping on the trap activates a steel spring which triggers the jaws to close and remain closed, cutting through skin, muscles and tendons. Even when used by the most diligent trapper, animals are left to suffer for hours as they frantically struggle to escape.

Eight states have banned or severely restricted the use of leghold traps, but they are still widely used by trappers in other states to catch raccoons, coyotes, bobcats, otters and other fur-bearing animals. In 1972, Florida banned the use of leghold traps without a special permit issued by the Florida Fish and Wildlife Conservation Commission. Even with a permit, only padded-jaw/rubber-jawed traps may be used. The mere possession of leghold traps where wildlife might be found is a crime in Florida.

Gander Mountain is a hunting, fishing, "outdoor lifestyle" superstore with five locations in Florida (Jacksonville, Lake Mary, Ocala, St. Augustine and Palm Beach Gardens). Leghold traps are available for purchase at these Gander Mountain stores (the traps on sale are not padded). The traps are sold next to Havahart live traps, owl decoys and other "pest" control products. Although the sale of these traps is technically not illegal, by offering the traps for sale alongside other, legal wildlife control products, Gander Mountain is sending a message that they are acceptable to use. Customers unaware of Florida law may purchase these traps and use them, therefore committing a crime—and harming wildlife.

You Can Help

Contact Gander Mountain and ask that leghold traps be removed from store shelves in Florida. Although our aim is to prevent the suffering of animals, when you write please focus on the fact that the sale of leghold traps in Florida encourages illegal activity. *Contact:*

An ugly side of the Miss Florida USA / Miss Florida Teen USA pageants

Each year the fur industry consumes millions of animals. The vast majority of the animals are raised on factory farms. Rows of tiny wire cages encrusted with dirt, clumps of fur and excrement line these intensive confinement facilities. Inside, thousands of mink, foxes or other animals are imprisoned for their entire lives and denied any opportunity to engage in natural behaviors.

animals are put to death by the cheapest available means, using killing methods designed to preserve the pelt, rather than minimize suffering. No humane slaughter law regulates fur farms. Along with neck snapping, gassing and poisoning, the fur industry refuses to condemn even the cruelest practices, such as electrocution, during which an electrode is inserted into the animal's rectum. This causes the animal to suffer from cardiac arrest. Most horrifically, because no killing method is fool-proof, undercover investigations have documented animals being skinned alive.

No less tragically, other skins used by the fur industry come from animals trapped in the wild. Suffering from excruciating pain, victims may be left to languish for days before a trapper arrives. Once on the scene, trappers often beat or stomp the animals to death. In addition, because traps are indiscriminant, each year thousands of dogs, cats, birds and other animals are crippled or killed by traps.



Due to the inherent cruelty and the overwhelming evidence of abuse in the industry, the fashion world has turned its back on fur. Many top designers, including Tommy Hilfiger, Ralph Lauren, Calvin Klein, Betsey Johnson and Kenneth Cole have taken a compassionate, fur-free stand.

Miss Cruelty USA. The Fur Information Council of America (FICA) is a long-time sponsor of Miss Florida USA and its sister pageant, Miss Florida Teen USA. Sadly, among the prizes for pageant winners are the skins of abused animals. By continuing to associate with FICA, pageant producers are supporting callous and unnecessary cruelty.

You Can Help

You can help ARFF send a message to pageant producers that the ugliness of fur has no place in a pageant.

- Speak up for animals abused by the fur industry! Recently, Bob Barker, famed animal rights activist, long-time ARFF supporter and former host of the national Miss USA competition, expressed his disappointment with Miss Florida USA's continued support of the fur industy in a letter sent to pageant producers. In his letter Barker stated,

"After my requests to discontinue the use of fur prizes were ignored, I was forced to step down from my position with the Miss USA Pageant. To my disappointment, I have been informed by ARFF that Miss Florida USA continues to be sponsored by the Fur Information Council of America. It saddens me greatly to know that Miss USA has yet to shed the cruel fur industry from its otherwise beautiful pageantry. What a terrible shame it is that Miss USA and all affiliated pageants have not recognized fur coats for what they are - the stolen skins of ruthlessly tortured animals."

ARFF needs your help to protect Muscovy ducks!

Florida is experiencing a population boom of Muscovy ducks and ARFF is increasingly called on to rescue injured birds or to resolve conflicts between those who enjoy the birds and those who view them as a nuisance. These birds are often the target of animal abuse and recently two ducks in Fort Lauderdale were actually shot with arrows and left to die. While this represents an exceptional event, many communities throughout Florida have resorted to hiring trappers to round up the ducks and kill them.

However, Florida communities now have the option to use a safe and humane tool to help control the burgeoning numbers of Muscovy ducks. Analogous to spaying and neutering dogs and cats, the recent development of OvoControl G, an oral contraceptive, is a significant innovation for the management of urban fowl. Unfortunately, the current registration of OvoControl G as a "Restricted Use Pesticide" hinders the availability and utility of the new product for use by ARFF.

You Can Help

Please contact your U.S. Senators and U.S. Representative and urge them to contact the Environmental Protection Agency's (EPA) Pesticide Division to encourage them to revise the labeling of OvoControl G to include an exception for use of the drug by ARFF. If the EPA allows an exception for the controlled use of the product by ARFF, we will be able to work with cities to help control populations of Muscovy ducks, thereby alleviating many problematic issues faced by communities around the state of Florida. *Contact:*

Help ARFF get iguanas out of South Florida pet stores

At PETCO stores in South Florida, young iguanas can be purchased for less than \$20. (PetSmart, its superstore competitor, does not sell iguanas.) Due to their low cost and small size, iguanas are often purchased by individuals who lack the knowledge and resources to properly care for them. Unfortunately, once these reptiles become too large or expensive to care for, they are often abandoned or released into the wild. Iguanas are able to thrive in South Florida's subtropical climate. These feral populations sometimes present unwelcome challenges for homeowners and as a result the reptiles are often cruelly mistreated. As one of Florida's leading retailers of pet products, PETCO is in a position to positively impact the growing problem of feral iguanas. In addition, in response to concerns raised by animal advocates, PETCO ended the sale of large birds and the company will phase-out rabbit sales in 2009.



Tell Broward County public schools to expel the circus

For-profit circus promoters are committed to luring schoolchildren with field trips, ticket giveaways and other promotions. ARFF addressed the Broward County School Board at their June meeting and called for the establishment of a district-wide policy prohibiting affiliations with animal circuses at all Broward schools.

During the presentation, ARFF Project Coordinator Amanda Burk showed undercover video footage from circus animal training and left the Board with a comprehensive packet of additional information, including a long list of Animal Welfare Act violations incurred by the Ringling Bros. Circus. Amanda made it clear that animals in the circus are used to sell tickets, not to teach a greater appreciation of nature. Instead, animal acts teach kids that chaining, caging, whipping, beating and humiliating animals are acceptable, and set an inappropriate example of humankind's responsibility toward animals.

You Can Help

Broward County Public Schools have the opportunity to act responsibly by adopting a policy not to support circuses with animal acts, but we need your help! Please contact the School Board and express your strong concern regarding the mental and physical toll of circus life for animals, as well as the safety risks—such as rampages, attacks and disease—to children in this environment. 
