Dogs don't want to be your security system

Most businesses protect their property with locks, fences, lights, cameras and security guards. Unfortunately, a few still turn to dogs. The life of a guard dog is one of loneliness and neglect. These dogs suffer through all types of weather extremes.

A recent article in the <u>Palm Beach Post</u> described the plight of dogs who are used to guard used car lots and junk yards. These are dogs who never know a family, a run in the park, or a nap on a bed. They are left, in solitude, all night. During the day while the business is open, they're frequently locked in cages from sunup to sundown. Often food and water are denied, while they swelter in poorly ventilated boxes.


Palm Beach County's ordinance only requires that dogs be removed from cages once every 12 hours; "adequate ventilation" must be provided once the temperature hits 90 degrees. These rules do not address the basic needs of any dog. As insufficient as these regulations are, they are among the best in Florida!

You Can Help

If you live in Palm Beach County, please send a letter to the Board of County Commissioners (find contact details here: www.pbcgov.com/countycommissioners). If not, please write to your county commissioners. Ask for new regulations, such as:

- A cage or room adequately ventilated at all times that is large enough for the dog to turn around in and perform natural behaviors;
- A maximum of 8 hours in the cage that includes a 15 minute walk every 4 hours;
- Food at least twice a day and fresh water at all times:
- · If outside, shade must be provided;
- Companies that rent out guard dogs should supply the county with a list of the companies that are using the dogs so that animal control can visit and inspect the conditions under which the dogs are living. In addition, the facility from which the dogs are rented must be inspected to meet minimum county standards.

If you know of a guard dog who is being abused or neglected, please take action. You may be the animal's only hope.




Good news from Tallahassee

The 2010 Legislative Session ended on April 30. We are happy to report that two important bills that will help animals in Florida—bills that we asked you to support—were approved and signed by the governor.

Stopping the trade in exotic reptiles. On June 3, Governor Charlie Crist signed Senate Bill 318. The bill will stop the breeding, sale and trade of Burmese pythons, African rock pythons, anaconda and Nile monitors, among other "reptiles of concern" in Florida. (A person who currently possesses one of these reptiles would be allowed to keep the animal for the remainder of that animal's life.) This important legislation will improve public safety, protect Florida's fragile environment and benefit animal welfare. During the 2010 legislative session, the bill passed both the Florida House of Representatives and the Florida Senate with unanimous votes. ARFF congratulates State Senator Eleanor Sobel and State Representative Trudi Williams, who introducted the legislation.

Horse protection. Since the beginning of 2009, there have been several disturbing cases of horses illegally killed for their flesh in Miami-Dade County and elsewhere in Florida. Senate Bill 1708 and House Bill 765, which also passed the Florida Senate and House of Representatives with unanimous votes, increases penalties for the unlawful killing of a horse. The legislation also strengthens the State of Florida's restrictions on the sale of horsemeat for human consumption. The changes will take effect on July 1, 2010. Thanks to State Senator Victor Crist, State Representative Luis Garcia, Jr. and State Representative Joseph Abruzzo for introducing this legislation.

Bad news, but there's always next year!

Unfortunately, not every pro-animal bill passed this year in Tallahassee.

<u>Protecting animals from sexual abuse</u>. For the third year in a row, Florida legislators failed to enact a ban on sexual contact with animals. In the Florida Senate, a bill introduced by State Senator Nan Rich was unanimously approved by four committees and the full Senate. The bill was sent to the Florida House of Representatives, but did not come up for a vote before the session ended.

<u>Spay/neuter surcharge</u>. Legislation introduced by State Senator Nan Rich and State Representative Scott Randolph would have required county's and municipalities in Florida to collect a \$15 surcharge for each violation of an ordinance relating to animal cruelty or control. The surcharge would be used to subsidize the costs of spaying or neutering dogs and cats in the community. The bills were approved by several committees, but unfortunately did not make it to the floor of the House or Senate for votes before the session ended. We hope that this bill will be reintroduced next year.

<u>Greyhound racing</u>. A last-minute amendment, filed by State Senator Charlie Justice, would have removed the requirement that dog tracks conduct live racing in order to also offer slots or poker. The amendment died for technical reasons, but if it had been approved, many dog tracks in Florida would almost certainly have chosen to end live racing to focus on the more profitable slots and poker.

Tell Palm Beach County public schools to expel the circus!

For-profit circus promoters are committed to getting schools on board with field trips, ticket giveaways and other promotions. ARFF has received several complaints of tickets being distributed in Palm Beach County schools. Animals in the circus are used to sell tickets, not to teach a greater appreciation of nature. Instead, animal acts teach kids that chaining, caging, whipping, beating and humiliating animals is acceptable, which sets an inappropriate example of humankind's responsibility toward animals.

Victories & Updates

Matt Block can't escape his past!

In early May, the Animal Transportation Association—whose members include FedEx, Continental Airlines and other companies that transport animals for zoos, farms and for scientific research—held its annual convention in Fort Lauderdale. Due to speak at the convention about "Global Primate Transport" was Matthew Block—a man ARFF is very familiar with.

In February 1990, workers at Bangkok's international airport heard sounds like the crying of human babies coming from crates labeled "Birds." On opening the poorly ventilated crates, they found six baby orangutans. Smugglers had stuffed them into the crates and shipped them to Thailand, with the final destination being Moscow. Four of the six babies, three of whom had been shipped upside-down, died. Matt Block, president of Miami-based Worldwide Primates, Inc., was soon identified as a member of the smuggling ring. When Matt Block went on trial for smuggling endangered wildlife, ARFF held demonstrations at the steps of the federal courthouse in Miami. ARFF President Nanci Alexander and other local animal advocates attended Block's court appearances. Block pled guilty to felony charges and was sentenced to 13 months in prison.

Unfortunately, Matt Block returned to the primate business shortly after he got out of prison. Today, Block and his family are one of the largest importers of primates for scientific research. In 2009, according to U.S. Fish and Wildlife Service records, Worldwide Primates, Inc. imported over 1,000 primates—crab-eating macaques, rhesus macaques and other monkeys—from China, Mauritius and elsewhere, to be bred and sold for scientific research.



When ARFF learned of Mr. Block's participation in the conference, we expressed our concerns to the Animal Transportation Association, and scheduled a protest. Shortly before the protest, ARFF learned that due to the controversy created by our planned protest, Matt Block had pulled out of the Animal Transportation Association conference!

Exotic pets no longer for sale at Flamingo Gardens

In late 2009, ARFF received complaints about the "Reptile & Alternative Pet Show," an event held several times each year at Flamingo Gardens, a botanical garden in Fort Lauderdale. ARFF staff attended one of the shows and found three types of boa constrictors on sale—including Colombian boas that can grow to 10 feet in length—in addition to ball pythons, iguanas, tegu (large, carnivorous lizards native to South America that are increasingly found in Florida) and many other exotic snakes, spiders and turtles.

ARFF contacted Flamingo Gardens and urged them to end their involvement in the sale of non-native reptiles and other exotic pets. We explained that due to their low cost and small size, animals such as ball pythons and iguanas are often purchased by individuals who lack the knowledge and resources to properly care for them. Unfortunately, once these reptiles become too large or expensive to care for, they are often abandoned or released into the wild. Others live miserable lives inside a glass aquarium.

We are happy to report that after hearing from ARFF, and many of ARFF's members in Broward County, Flamingo Gardens decided to no longer host such events. And even better, an event hosted by Flamingo Gardens in June explored the threat that escaped and released exotic reptiles pose to Florida's environment.

Another venue pulls the welcome mat from Liebling Bros. Circus

The Liebling Bros. Circus, and their sad elephant "Nosey," had been a regular visitor to the Renninger's flea market in Mount Dora. In April, following a weekend of performances by the circus, ARFF representatives discussed the circus with Renninger's manager and was assured that the circus would not be invited back in the future.

Earlier this year, the North Lake Flea Market in Fruitland Park confirmed that the Liebling Bros. Circus would not be invited back after a monkey escaped from his cage before a performance at the market in 2009.

Maude the elephant deserves a happy retirement

Mary, one of two elephants at the Central Florida Zoo, died in March at age 63. Mary's death left her companion of 27 years,

Maude, facing an uncertain future.

Because the Association of Zoos & Aquariums strongly discourages keeping female elephants alone, the Central Florida Zoo has started looking for a new home for Maude. Instead of relocating Maude to another zoo, where she would be stuck in another small and unnatural exhibit, ARFF feels that Maude deserves retirement to a large, natural-habitat elephant sanctuary, such as The Elephant Sanctuary in Tennessee, or the PAWS sanctuary in California, where she could enjoy natural conditions and elephant companions of her choosing.

U.S. Congressman Ted Deutch joins ARFF's Board of Advisors

ARFF is honored that Florida's newest Member of Congress has agreed to join our Board of Advisors. In a special election in April, Ted Deutch was elected to replace retiring Rep. Robert Wexler in Florida's 19th congressional district, which includes parts of Palm Beach and Broward counties. Deutch had previously served in the Florida State Senate.

Congressman Deutch was sworn in on April 15 and quickly got to work. He has signed on as co-sponsor of several important animal protection measures, including:

- H.R. 5092, a law to ban the distribution and sale of cruel "crush" videos;
- H.R. 4870, the Healthy School Meals Act, a bill that would help school food service programs serve more fruits, vegetables, and healthy vegetarian meal options;
- H.RES 1420, a resolution congratulating the Convention on International Trade in Endangered Species (CITES) on its 35th anniversary and urging stronger protections for the polar bear, sharks and other endangered species;
- H.R. 669, the Nonnative Wildlife Invasion Prevention Act, an act to prevent the introduction and establishment of nonnative wildlife species;
- H.R. 2811, an act to ban the interstate commerce and importation of pythons.


