The hooked prod that animal trainers use to coax and frighten the elephants into performing should be outlawed and so should circuses and carnivals featuring performing animals. Research has proven time and again that animals are abused who are forced to be in the circus route. Lack of exercise, poor feeding and grooming, inadequate housing and the use of drugs to "anesthetize" or allow the animals to become lethargic is grossly underreported and grossly a common factor in this grisly field of entertainment.
